



**Sacks Morasha Jewish Primary School Supplementary Information Form  
(2025/6)**

Please note that this form is NOT the same as the United Synagogue CRP application form. In order to apply for Sacks Morasha, you will need to complete this form which is specific to the school and year of entry.

For Section 1, you must register with the synagogue you propose to attend, as well as completing this form. Registration can be made by email or online: see your synagogue website.

**You should send a completed copy of this form to the school to arrive no later than 15<sup>th</sup> January 2025. Email or post are acceptable.**

If the form is not received in time, it may not be possible to treat the child as a religious practice priority applicant.

To obtain points in sections 1, 2 and 3, the parent/guardian must complete this form and take, or send, it to the person(s) referred to in those sections.

**This form must be completed regardless of sibling status.**

The school cannot consider a CRP which does not have the relevant declarations and it is the responsibility of the parent/guardian to approach the relevant person(s) to obtain a letter of confirmation if they are unable to have parts of the form signed.

The relevant person(s) may decline to sign this form where the parent/guardian or the child is not personally known to them and/or cannot vouch for the parent/guardian or the child.

Please ensure you have signed section 4 and that all relevant sections are completed.

**SECTION 1 ORTHODOX SYNAGOGUE ATTENDANCE. Between 31<sup>st</sup> May 2024 and 4<sup>th</sup> January 2025**

Since 31<sup>st</sup> May 2024 how many times have you or other parent/guardian attended Friday night or Shabbat morning synagogue religious services? Please note, only one attendance can be registered for every Shabbat, i.e. either Friday night or Shabbat Morning.

Dates of Shabbat attendance need to be verified by the Rabbi or authorised official of each synagogue attended, either by completing the declaration below or by attaching a signed letter. Printed CRP letters with dates of attendance are also acceptable. You should refer to the relevant synagogue website for more details about service times and locations.
