- The school cannot consider a CRP which does not have the relevant declarations and it is the responsibility of the parent/guardian to approach the relevant person(s) to obtain a letter of confirmation if they are unable to have parts of the form signed.
- The relevant person(s) may decline to sign this form where the parent/guardian or the child is not personally known to them and/or cannot vouch for the parent/guardian or the child.
- **This form must be completed regardless of sibling status.**
- Please ensure you have signed section 4 and that all relevant sections are completed.

- **You should send a completed copy of this form to the school to arrive no later than 15th January 2026. Email or post are acceptable.**
- If the form is not received in time, it may not be possible to treat the child as a religious practice priority applicant

SECTION 1 ORTHODOX SYNAGOGUE ATTENDANCE. Between 30th May 2025 and 10th January 2026

- For this section, you must register with the synagogue you propose to attend, as well as completing this form. Registration can be made by email or online: see your synagogue website.

- Dates of Shabbat attendance need to be verified by the Rabbi or authorised official of each synagogue attended, either by completing the declaration below or by attaching a signed letter.

- Printed CRP letters with dates of attendance are also acceptable. You should refer to the relevant synagogue website for more details about service times and locations.
